

WHO NEEDS REGISTERED TECHNICIAN OR CERTIFIED COMMERCIAL PESTICIDE APPLICATOR TRAINING & CERTIFICATIONS?

Registered Technicians

- Operate under the supervision of a commercial applicator when applying restricted-use pesticides
- Have not completed the requirements for commercial certification
- Can apply general use pesticides without supervision

Commercial Applicators (for Hire)

- Use any pesticides on others' property in exchange for compensation
- Must work for a company with a Pesticide Business License

Commercial Applicators (Not for Hire)

- Use any pesticides as part of job duties, on property owned or leased by them or their employers
- Use pesticides as a government employee
- Use pesticides on any area open to the general public at the following establishments: educational institutions, health care facilities, day-care facilities, convalescent facilities
- Use pesticides where open food is stored, processed or sold
- Use pesticides on any recreational land over five acres

Directions to VCE—Stafford

From Culpeper (Route 3) Follow Route 3 to north Jefferson Davis Highway (US Route 1); continue north on Jefferson Davis Highway into Stafford County (approx. 2 miles), continue north on US 1 for approximately 6.5 miles until Log Cabin Restaurant on left. Turn left just before Log Cabin Restaurant. Proceed to first left into Rowser Building parking lot. VCE offices are in Rowser Building. **Please use parking lots on the right as you enter the parking area.**

From Interstate 95: Take Courthouse Rd. (Rte. 630) east, Exit 140. Proceed east for about 1 mile to the intersection of Courthouse Road (Rte. 630) and Jefferson Davis Highway (US Route 1) Turn right (south) onto Jefferson Davis Highway (US Route 1) and continue to Log Cabin Restaurant on right (approx. 1.3 miles). Turn right on road immediately past Log Cabin Restaurant. Proceed to first left into Rowser Building parking lot. VCE offices are in Rowser Building. **Please use parking lots on the right as you enter the parking area.**

Taking the Exams

The exams can be taken at any time at a DMV Center which offers electronic testing if you have an authorization letter. As part of this training, a VDACS representative will administer the Registered Technician or Commercial Pesticide Applicator and category 3A, 3B and 6 exams onsite **February 21** from 9am until noon. You have the option of taking the exams at DMV electronically on your own.

To sit for the exams, you must bring a photo ID and a Letter of Authorization from VDACS, OPS (Office of Pesticide Services).

If you wish to take any of these exams onsite, you must do the following:

Determine which certification to apply for:

- Registered Technician
- Commercial Pesticide Applicator (categories 3A, 3B, or 6)
- Call VCE Stafford 540-658-8000 or your local Extension Office and request the appropriate application form OR

Complete the Commercial Pesticide Certification Application and mail it by **January 15** along with appropriate payment to: VDACS, P.O. Box 526, Richmond, VA 23218.

- You will receive a Letter of Authorization which you **MUST** bring with you (along with photo ID) in order to sit for the exams. **No Letter of Authorization or photo ID, no exam.**
